# Riverside County Per Diem Tentative Agreement Summary

The following information provides highlights of the proposed contract settlement with Riverside County SEIU 721 Per Diem members and the County of Riverside:

- Base Salary Increases ranging from 2.71% 79% depending on classification

- Premium Pay Critical Care Pay equal to SEIU full-time employees
- Shift Differential Pay
- Forensic Mental Health Differential Pay
- Psychiatrist Call-In Pay
- Psychiatrist Medical Care Assignment Pay
- Preceptor Pay
- Call Back Pay
- On-Call Pay \$3/hour up to 12 hours for each on call assignment
- Grievance Procedure
  - grievance mediation to settle grievance disputes
- Name Clearing hearing in the event of termination
- Union Rights Language
  - 2 stewards for Per Diem Bargaining Unit
  - Labor Management Committee
  - SEIU Representatives access to new employee orientations
