Nomination Notice 2019

Nomination Process

Nominations for the Offices of President, Vice President, Secretary and Treasurer, and forty-one (41) board member seats on the SEIU Local 721 Executive Board, will be accepted by Petition.

Members who have been in continuous good standing for the preceding two (2) years are eligible to be nominated. Eligible candidates may begin to collect signatures from current full dues-paying members in good standing starting on January 18, 2019.

Petitions may be returned by:

All nominating petitions are due and must be received by 5:00 p.m. on Friday, February 22, 2019.

Petition signatures will be verified for eligibility on a rolling basis. Candidates are encouraged to collect signatures and submit petitions early for ample time to correct any errors. Nominees will be notified of their eligibility and next steps, if any, shortly after the due date.

A blank petition is on the reverse side of this Nomination Notice. Additional petitions will be available at all SEIU Local 721 offices, and can be downloaded at www.seiu721.org starting on January 18, 2019.

Executive Board Officers

Pursuant to Article 7, Section D of the SEIU Local 721 By-Laws, qualifications for office are:

- **Executive Board**
Two years as a Represented Member in good standing; petition signatures from **50** Represented Members in good standing to qualify for the ballot. A member may submit a nomination petition for only one office on the Executive Board during any election.
- **Secretary, Treasurer, and Vice President**
Two years as a Represented Member in good standing; petition signatures from **75** Represented Members in good standing to qualify for the ballot.
- **President**
Two years as a Represented Member in good standing; petition signatures from **100** Represented Members in good standing to qualify for the ballot.

In addition to the four (4) at-large offices, the election will fill forty-one (41) Executive Board seats pursuant to Article 7, Section C of the SEIU Local 721 By-Laws. Members in Region 1 (L.A. County) will elect fifteen (15) Board members; Members in Region 2 (L.A./O.C. Cities) will elect nine (9) Board members; Members in Region 3 (Inland Area) will elect nine (9) Board members; and Members in Region 4 (Tri-Counties) will elect eight (8) Board members.

Pursuant to Article 7, Section E of the SEIU Local 721 By-Laws, the Term of Office is for three (3) years.

Election Committee

Pursuant to Article 13 of the SEIU Local 721 By-Laws, an Election Committee must be formed to oversee local-wide elections. The following Election Committee members have been appointed by the Executive Board as representatives from each Region: Lorraine Cavuoti, Joan Marks and Frank Martinez (Region 1); Johnny Clark, Michael Fabregas, Andrew Ortiz and Robert Potter (Region 2); Nancy Novak, Johnny Ortega, Maria Sneed and De'Yon Williams (Region 3); Rob Adam Perry and Maureen Stutt (Region 4).

Pursuant to Article 13 of the SEIU Local 721 By-Laws, the Executive Board Officers election will be conducted by a neutral third party vendor, MK Election Services, that will create and send the election notices, ballots and instructions to all eligible member voters by March 29, 2019. The ballots must be received at a designated PO Box by 9:00 a.m. on Friday, April 12, 2019 in order to be counted.

SEIU Local 721 members are invited to observe the ballot count which will be held on Friday, April 12, 2019 at the SEIU Local 721 headquarters at 1545 Wilshire Blvd., Los Angeles, 90017, beginning at 9:45 a.m. in the auditorium. Additional information will be forthcoming.
