

Service Employees International Union, Local 721

LICENSE AGREEMENT

1. You (“Licensor”) hereby grant to Service Employees International Union, Local 721 (“Licensee,” “SEIU Local 721,” or “Union”) and its affiliates the irrevocable, non-exclusive, royalty-free right and license to have access to, store, display, reproduce, use, modify, broadcast, perform, display, distribute, and exploit in the manner and for the purposes below, all images and content sketches, still pictures, artwork, sketches, digital video files, writings and any such other materials as may be submitted by Licensor under this agreement (collectively, “the Submission”) including, without limitation, the right to include the Submission (as provided by Licensor and/or as edited by Licensee) as well as the name of the Licensor (and copyright owner, if different than Licensor) on the websites produced by SEIU Local 721 and its affiliates and in social media posts on accounts operated by SEIU Local 721 and its affiliates and in all media now known and later conceived or created. Licensee acknowledges that it will receive no compensation for granting the rights herein, and that consideration for this agreement shall be the possible showing of the Submission on our website and/or social media account(s) should the material be chosen for use.
2. In connection with the Submission, Licensor warrants and represents for the express benefit of Licensee that:
  - a. He or she is 18 years of age or older, and has the right to enter into and perform this Agreement and grant Licensee all the rights granted herein in that it either owns the copyright to the image or video or has a license to control the exhibition and distribution rights thereto; and
  - b. There are no agreements, nor shall Licensor enter into any agreements, which would prevent the fulfillment of this Agreement or impair or conflict with the rights granted hereunder; and
  - c. The events in the Submission that purport to be factual have not been staged or altered and/or the Submission depicts the events and persons as described to Licensee by Licensor; and
  - d. The content does not violate any local, state, or federal law relating to patient privacy or confidentiality; and
  - e. The content does not contain copyrighted materials owned by others (including music, photographs, sculptures, paintings and other works of art or images published on or in websites, television, movies or other media) without permission; and
  - f. The content does not contain materials embodying the names, likenesses, photographs or other indicia identifying any person, living or dead, without permission; and
  - g. That neither content nor the manner in which it was obtained violates or has violated any local, state or federal law or the rights of any individual or entity.
3. Licensor agrees at all times to indemnify, defend and hold harmless Licensee, its related subsidiary and parent organizations, and affiliates, and their respective

officers, directors, employees, sublicensees and agents, from any and all claims, damages, liabilities, costs and expenses, including reasonable legal fees, caused by or arising from: (i) any misrepresentation concerning the Submission or elements thereof by the Licensor; and/or (ii) any distribution or other authorized use of the Submission or elements thereof by the Licensee; and/or (iii) the breach of any warranty or representation made by Licensor hereunder, including, but not limited to, any claim relating to rights in the Submission (i.e., claims of copyright, unfair competition, breach of contract, fraud, misappropriation, invasion of privacy, and right of publicity).

4. Nothing contained in this Agreement shall be deemed to obligate Licensee to post the Submission on the Union's website or in its social media accounts.
5. SEIU Local 721 may, but is not obliged to, edit submissions for grammar, spelling, and/or insignificant profanity.
6. This Agreement and all collaterally related issues shall be governed by California law. Federal and state courts situated in Los Angeles, California shall have sole jurisdiction and venue to resolve disputes hereunder and the parties hereto irrevocably submit to such jurisdiction and venue (and waive any claim that such forum is inconvenient).
7. This Agreement contains the entire agreement of the parties, supersedes all prior agreements on this subject matter and cannot be modified orally.
8. Licensor understands and accepts that Licensor's submissions may be the same as or similar to submissions made by others. All submissions remain the property of SEIU Local 721 and will not be returned or acknowledged. Licensor further acknowledges and agrees that any and all Submissions may be used, in whole or in part, by SEIU Local 721 and that any Submission made is not being made in confidence or trust and that no confidential or fiduciary relationship is intended or created between Licensor and SEIU Local 721 in any way, and that Licensor has no expectation of any compensation or consideration of any type.
