- 4. All employees who are below the new start rates will be moved up to the new rates, effective the beginning of the first pay period following ratification of this tentative agreement.
- 5.All employees who are below the new wage table rate will be moved to the new wage table step in accordance with their classification seniority effective the first pay period following ratification of this tentative agreement.
- 6.Retro Activity Bonus: Each employee hired before November 27, 2021, who are active on payroll at the time of the of the bonus payout, shall receive a lump sum bonus according to the following schedule, effective the first pay period following ratification of this tentative agreement:
 - a. Employees who have fifteen years or more of service as of the date of execution of this agreement shall receive a \$3,250.00 dollar lump sum bonus.
 - b. Employees who have between ten (10) and fifteen (15) years of service as of the date of execution of this agreement shall receive a \$2,750.00 dollar lump sum bonus.
 - c. Employees who have between five (5) and ten (10) years of service as of the date of execution of this agreement shall receive a \$2,250.00 dollar lump sum bonus.
 - d. Employees with less then five (5) years of service as of the date of execution of this agreement shall receive a \$1,750.00 dollar lump sum bonus.
- 7. All employees will also receive any across the board (ATB) increase negotiated as part of the National Addendum negotiations in addition to the increases provided herein. The ATB increase will be subject to any eligibility rules spelled out in the National Addendum.
- 8. Longevity Pay:
- e. Effective January 1, 2023:
 - i. All employees with sixteen (16) years or more of service on January 1, 2023, and all employees that reach sixteen (16) years of service after January 1, 2023, but on or before December 31, 2024, shall receive a one dollar and sixty cents (\$1.60) per hour base rate increase. The longevity pay increase will not continue past December 31, 2024.
