



Dear SEIU Local 721 Member,

SEIU members from the United States and Canada will participate in the Service Employees International Union Convention in Philadelphia, Pennsylvania from May 18-22, 2024. The SEIU Convention is held every four years.

This Notice is to inform SEIU Local 721 members that 35 delegate seats are vacant and will be filled by a formal nomination and election process in accordance with the SEIU Local 721 Bylaws, the SEIU Constitution, and federal law. The 35 seats are divided proportionally by region based on the total number of full dues-paying members. Please see the "Summary of Convention Delegates by Region" on the back of this Notice.

Nominations will be accepted by petition, which means interested members must submit at least 10 names and signatures from dues-paying members from their specific region only. Please use the attached petition form and refer to the Summary of Convention Delegates by Region to determine your regional category.

The names and signatures will be verified and if at least 10 signatures are valid, the nominee's name will be added to the ballot as a candidate.

An independent third-party agency was retained to conduct the election and will send ballots and instructions to dues-paying members on March 4, 2024. **The ballot count will occur on March 22, 2024.**

**The deadline to return nomination petition is 5 pm on February 23, 2024 to the SEIU Local 721 office in your region, or by email to [DelegateElection2024@seiu721.org](mailto:DelegateElection2024@seiu721.org).**

**Candidate Eligibility Requirements:** You must be a member in good standing for two continuous years preceding your nomination; cannot be convicted of a disqualifying crime; and cannot be a current elected officer of the Local.

Please be advised that elected delegates are responsible to use and request their own time off work to travel and attend the convention beginning May 18, 2024. Prior to running for a delegate seat, please be sure you have the time off available during the convention dates. SEIU Local 721 will cover airfare, accommodations, and a daily per diem per delegate.
