

# SEIU Local 721 Executive Board Officers Nomination Notice 2025

## Nomination Process

Nominations for the Offices of President, Vice President, Secretary and Treasurer, and forty-one (41) board member seats on the SEIU Local 721 Executive Board, will be accepted by Petition.

Members who have been in continuous good standing for the preceding two (2) years are eligible to be nominated. To be in "good standing," a member must be current on all dues owed for the 2-year period ending on December 31, - 2024. Members will have until February 21, 2025 to make up any missed dues payments without losing eligibility.

Eligible candidates may begin to collect signatures from current full dues-paying members in good standing starting on January 21, 2025. Petitions may be returned by:

All nominating petitions are due and must be received by 5:00 p.m. on Friday, February 21, 2025. Petition signatures will be verified for eligibility on a rolling basis. Candidates are encouraged to collect signatures and submit petitions early for ample time to correct any errors. Nominees will be notified of their

eligibility shortly after the due date. A blank petition is on the reverse side of this Nomination Notice. Additional petitions will be available at all SEIU Local 721 offices, and can be downloaded at [www.seiu721.org](http://www.seiu721.org) starting on January 21, 2025.

## Executive Board Officers

Pursuant to Article 7, Section D of the SEIU Local 721 Bylaws, qualifications for office are:

- **Executive Board**  
Two continuous years as a Represented Member in good standing; petition signatures from **50** Represented Members in good standing to qualify for the ballot. A member may submit a nomination petition for only one office on the Executive Board during any election.
- **Secretary, Treasurer, and Vice President**  
Two continuous years as a Represented Member in good standing; petition signatures from **75** Represented Members in good standing to qualify for the ballot.
- **President**  
Two continuous years as a Represented Member in good standing; petition signatures from **100** Represented Members in good standing to qualify for the ballot.

In addition to the four Executive Officers, the election will fill forty-one (41) Executive Board seats pursuant to the SEIU Local 721 Bylaws. Members in Region 1 (L.A. County) will elect fifteen (15) Board members; Members in Region 2 (L.A./O.C. Cities) will elect nine (9) Board members; Members in Region 3 (Inland Area) will elect nine (9) Board members; and Members in Region 4

(Tri-Counties) will elect eight (8) Board members.

Pursuant to Article 7, Section E of the SEIU Local 721 Bylaws, the Term of Office is for three (3) years.

## Election Committee

Pursuant to Article 13 of the SEIU Local 721 Bylaws, an Election Committee must be formed to oversee Local-wide elections. The following Election Committee members have been appointed by the Executive Board as representatives from each Region: Shawnte Beacham Houston and Krystal Wilson (Region 1, LA County); Jimmy Francis and Derrick Smith (Region 2, LA/OC Cities); Jessica Tobin and Marcos Coronel (Region 3, Inland); Joe Valdivia and Steve Hernandez (Region 4, Tri-Counties).

Pursuant to Article 13 of the SEIU Local 721 Bylaws, the Executive Board Officers election will be conducted by a neutral third party vendor, True Ballot, that will create and mail ballots and instructions to all eligible member voters by March 24, 2025. The ballots must be received at a designated PO Box by 9:00 a.m. on Friday, April 25, 2025 in order to be counted.

SEIU Local 721 members are invited to observe the ballot count which will be held at 9:00 a.m. on Monday, April 28, 2025 at the SEIU Local 721 headquarters at 1545 Wilshire Blvd., Los Angeles, 90017.
